What the Governor Should Have Addressed

- Reducing Child Poverty: EITC
- Early Support: 0-3 Strategies
- Connections 0-8: Best of Both Systems
- Reform K-12: Equity Focus
- Connections to Higher Ed and Workforce:
 Extended Learning; 5th and 6th Year



The state budget, as the single most powerful expression of the state's priorities, is a powerful tool for either improving equity or widening gaps.

Steps Forward in the FY2013 Budget

- Affordable Care Act → increased reimbursement rates for PCPs. MI took it a step further and also increased reimbursement rates for OB/GYNS
- \$16.6 million to expand the Healthy Kids Dental to additional counties, which included Calhoun
- \$2 million for lead abatement in homes
- \$5 million increase for Great Start Readiness
 Program



Mixed Results in the FY2013 Budget

- \$20.9 million to fund autism spectrum disorder treatment for Medicaid and MIChild eligible children through age 18
- Intended one time funding to address infant mortality, health disparities, and pregnancy prevention
- Small increase to the minimum per pupil foundation allowance for K-12



Steps Backward in the FY2013 Budget

- No changes made to FIP, FAP, or EITC
- Reduction to child care subsidy program
- No funding for before- or after-school funding
- No increases for opportunities for the 5th and 6th year of high school

MDE – Office of Great Start

- \$196.8 million for the Office of Great Start (OGS), including \$156.8 million for the Child Care and Development program. The OGS has responsibility for the following programs:
 - Great Start Readiness Preschool program.
 - Early Childhood Block Grant (formerly funding for Great Start Collaboratives and Great Parents/Great Start).
 - Preschool special education.
 - Early On.
 - Head Start Collaboration.
 - Child Development and Care (CDC) program.
 - 21st Century Community Learning Centers



Great Start Programs

- Great Start Readiness Program (GSRP): combine competitive and school-based program and provided a \$65 million increase for a total of \$174.3 million. Intent language for an additional \$65 million increase in FY2015. The per slot allotment increased from \$3,400 to \$3,625.
 Other policy changes to GSRP include:
 - Serving most at-risk
 - Support transportation
 - 3 star requirement in GSQ
 - Sliding scale fee for families above 300%
- Early Childhood Block Grant: \$10.9 million



K-12 Funding

- Foundation allowance: maintains the basic foundation allowance at \$8,019 per pupil, but includes \$24 million for an equity payment of up to \$7,000 from \$6,966.
- Best practices grants: reduced to \$25 million to districts that have met 7 out of 8 best practices criteria for a maximum payment of \$16 per pupil (down from \$52 per pupil in FY2013).
- Performance-based funding: maintained at \$30 million
- Student-centric learning grants: \$8 million
- At-risk support: maintains funding at \$309.0 million
- Virtual learning: \$10 million for new Digital Learning
 Innovation to expand blended and online learning to students
- MPSERS support

Intermediate School Districts

- General operations: maintained at \$62.1 million.
- Competitive grants: As in FY2013, \$2 million is earmarked to ISDs to be eligible for a 3.2 percent increase if they now meet five out of six performance criteria (previously had to meet four of the criteria): consolidate and competitively bid services, support technology integration, publish a dashboard of outcomes that includes budget information, develop information management system in coordination with other ISDs, and hold its own health insurance policy.



Health

- Medicaid expansion
- Healthy Kids Dental Program: \$11.6 million (\$3.9 million in state general funds) to expand the Healthy Kids Dental program.
- *Autism treatment*: \$39.5 million
- Health and Wellness Initiative: \$2.7 million cut to programs that promote healthy behaviors and wellness, and reduce infant mortality and obesity
- Mental Health Innovations: new investment of \$5 million in general funds/general purpose dollars (GF/GP) to support three service initiatives
- School-based health: maintains funding for child and adolescent health centers at \$3.6 million and school-based health services at \$131.5 million

Welfare

- No changes to FIP, FAP, or EITC
- Pathways to Potential: \$6.2 million in new investment – service delivery model that locates DHS staff in local public schools
- Youth in transition: reduces funding from \$14.7 million to \$14.5 million



Missed Opportunities

- Maintains harmful changes to FIP, FAP, and EITC
- Maintains funding to maternal and child health
- No improvements to the child care subsidy program.
- No increases in 0-3 programming.
- No increases in before- or after-school funding
- No increases for extended learning programs and opportunities for the 5th and 6th year of high school.



Federal Budget

- The federal budget, like the state budget, indicates federal priorities
- Much of federal support is focused on reducing disparities and increasing equity
- Federal funds support 41 percent of Michigan's total state budget:

- DCH: 64%

- DHS: 82%

- MDE: 74%



The Next "Fiscal Cliff"

- First "fiscal cliff" averted with the American Taxpayer Relief Act of 2012
- March 1: the sequester is triggered:
 - 2,300 children would lose Head Start and Early Head Start services
 - Up to 900 families would lose access to child care
 - 4,400 fewer children will receive vaccines
 - Lose \$22 million in Title I funding
 - Lose \$20.3 million in special ed funding
 - Lose \$1.7 million for job search assistance, referral, and placement, meaning around 54,400 fewer people will get the help and skills they need to find employment.
- March 27: continuing resolution expires
