## Burma Center Draws Families Focused on Early Childhood Issues Battle Creek Parents, Caregivers Pose Questions before Candidates Wednesday

Battle Creek – The state of the community's infants and toddlers and their families will take center stage at an early childhood-focused forum for candidates in the 44<sup>th</sup> state House and 18<sup>th</sup> state Senate races on **Wednesday, Sept. 28 (5:30-7 pm)** at The Burma Center, 765 Upton Ave., in Springfield.

Organizers from <u>The Burma Center</u>, <u>Pulse</u>, <u>Voces</u> and the <u>Southwestern Michigan Urban League</u> are working together with statewide advocates from <u>Think Babies Michigan</u> and <u>Michigan's Children</u> to host the program. Interpreters will be available for both Burmese & Spanish speaking attendees.

The event is targeted to community parents, care providers, policy-makers, and other members of the public who value exploring how every child can have the best start in life, leading to later success in school and life. Issues will include child care, perinatal support and home visiting, and *Early On* services for children 0-3 with disabilities or developmental delays.

This is a nonpartisan forum – not a debate. The forum's format will provide each candidate with one minute to introduce themselves, and answer questions prepared by families. The order of questions will rotate among the candidates. The sponsoring organizations do not endorse candidates, but are committed to voter and candidate education and engagement.

Invited candidates include: state **Rep. Jim Haadsma** (D) and challenger **David Morgan** (R) in Michigan's 44<sup>th</sup> State House District, which includes the city of Battle Creek, northern Calhoun County, and Albion; as well as state **Rep. Thomas Albert** (R) and **Kai De Graaf** (D) in the 18<sup>th</sup> State Senate district, located in the city of Battle Creek, Barry County, and parts of Allegan, Ionia, and Kent counties.

"Creating an early childhood system that ensures every child has an opportunity to thrive requires that our policy-makers know what issues are important to families," said **Kathy Szenda Wilson**, co-executive director of Pulse at the W.E. Upjohn Institute for Employment Research. "By hosting a candidate forum, we are providing an opportunity for our local candidates to hear directly from our families as well as key local stakeholders they trust."

**Matt Gillard**, president & CEO of Michigan's Children, the Lansing-based, statewide public policy and advocacy organization, will moderate. "Early childhood has truly emerged as an issue policy-makers must pay attention to because families demand it, and our future citizens, workers and leaders require it. Families of

young children face a great deal of challenges today, and it says a lot about Battle Creek to have civic groups united to bring concerns candidates.

"This is what the election process is all about - voters speaking up, and candidates listening to their constituents in order to make policy decisions in the best interest of kids and families," Gillard added.
